Relevance of the research issue. Today we are observing a growing escalation of terrorist activity from the outside, as a separate extremists and terrorist groups and entire terrorist organizations. The most dangerous terrorist organization in the world today is «Islamic state». Unlike «Al-Qaida», have not been a great interest for the control of territory, «Islamic state» is trying to create elements of a true state on its controlled lands. It established clear lines of authority, system of taxation and of education and sophisticated propaganda.

Terrorist activity of the «Islamic state» and methods of dealing with him is not enough studied in foreign and domestic literature, political resistance to international terrorism provided in the framework of various international institutions, additional needs, a comprehensive, multilateral review and specific analysis, which causes the relevance of the research issue.

The object of research is international terrorism, as a threat to the national security of States.

The subject of research is the role of international cooperation to combat terrorism of the «Islamic state» in contemporary terrorism, and possible threats to the security of States.

The purpose is to study the modern system of international cooperation in the fight against terrorism on the example of the fight against the «Islamic state».

Research objectives:

- to consider international terrorism in the context of threats to the national security of States;
- to identify the international legal forms of cooperation between States to counteract terrorism;
- to consider the “Islamic state” as a threat to the security of modern States;
- to determine the prospects of cooperation between Russia and other States in fighting against international terrorism.

Scientific novelty: It is explored the concept and nature of international terrorism, and revealed that modern international terrorism has social and technological potential, and resistance to it became a structural factor in ensuring the national security of States.

It is researched methods of dealing with the terrorist organization «Islamic state», and identified that at the moment there is an objective basis for the formation of the international antiterrorist coalition capable of joint efforts to counter terrorist tendencies.

Structure: two chapters, four paragraphs, the conclusion, bibliography list of used literature from 148 sources, including 55 sources in foreign languages. The total volume is 73 pages.

Summary: International terrorism and its implications for today are one of the major and most dangerous problems of the modern world. This phenomenon touches both poor and rich, industrial and economically developed countries. The reality of our time is that international terrorism threatens the national security of States, entail enormous political, economic, financial, moral and human loss of life. International terrorism in its content and main forms of manifestation is equally complex social-political phenomenon like terrorism in General, Evidence of its danger to society can serve as a persistent and often unsuccessful attempts by individual States to establish an effective system to counter terrorist activities. This phenomenon is becoming common practice in the resolution of territorial, ethnic and inter-confessional disputes in the areas of ethnic conflicts.

In the fight against international terrorism you should take into account the new quality and its global dimension, what allows to conclude that the threat of international terrorism to the national security of States is a long-term threat. This threat will continue to have very serious consequences and a real impact on various aspects in the development of the modern system of international security. At the same time it should be determined proportionally the place and the quality of the threat of international terrorism other threats and challenges, as States ' national security and international security as a whole.

International legal forms of cooperation, as well as various political instruments against international terrorism, are guided for the creation and full functioning of the various organs, organizations that have a counter terrorism focus. Russia, like several other States, such as China, India, Brazil, Iran etc. is committed to solving various world problems exclusively by legal means and methods, listening and considering the views of all interested States.
