Relevance of the research issue is that the changing geopolitical landscape in the era of the new world order has had a significant impact on subsequent developments in the world, the balance of power and foreign policy guidelines of some States, in particular Turkey. Recently the Turkish diplomacy is characterized by the activity of its foreign policy, which is associated primarily with approval by strengthening its geopolitical and economic position.

Today Turkish factor began to play a role in virtually all matters in the international arena, especially in the context of the processes taking place in the middle East. More recently, the role of Turkey as a global regional player seemed insignificant because of internal weaknesses, political, and historical heritage. Now Ankara is committed to actively shaping its foreign policy, to define their interests on a wide range of issues, as well as to defend their positions, as this was not done since the days of the Ottoman Empire, which explains the relevance of the research issue.

The purpose to analyze multi-vector foreign policy of Turkey in the modern world.

- to identify the main factors of the formation of the modern foreign policy of the Republic of Turkey;
