The relevance of the research work: Relations between nations, peoples, ethnic groups, as history shows, were often tense and tragic. Conflicts between different ethnic groups, in which the parties often resort to violence, are a constant companion of human civilization. The problem of the inter-ethnic conflicts for the multiethnic of the states as in practice it becomes clear is especially actual that to build and maintain the steady international peace – quite difficult and laborious work.

For Russia as the multiethnic state the problem of optimization of interethnic communication and prevention of interethnic conflicts is extremely urgent. In this regard, there is a need to find new ways, especially in the framework of the theory and practice of Conflict

The object of the study: ethnic tensions and conflicts.

The subject of the study: prevention of ethnic tensions and conflicts in the Russian Federation.

The research purpose is to generalize the system of state opposition to interethnic variance and conflicts in the Russian Federation on the example of the Stavropol Region.

The research goals are:

1. To examine ethnic tensions and conflicts in the interpretation of western and domestic specialists in conflict resolution techniques.
2. To estimate ethnic tensions and conflicts in the regulatory legal and political documents of the Russian Federation.

3. To analyze the strategies of the state national policy of the Russian Federation for the period up to 2025 as the basis for state opposition to interethnic variance and conflicts

4. To study the state of interethnic relations in the Stavropol region: problems and contradictions.

5. To select normatively legal and political framework to counter ethnic tensions and conflicts in the Stavropol region.

6. To consider the Stavropol Territory Committee on Nationalities and Cossacks as the subject of the prevention of inter-ethnic contradictions and conflicts.

The theoretical and practical significance: The theoretical significance of this work lies in the fact is that as a result of the carried-out work a certain theoretical notion of inter-ethnic contradictions and the conflicts developed and became stronger, both in the world as a whole, and on the former Soviet Union, and also many categories and concepts of conflictology are specified.

The practical significance of the work lies in the fact that throughout the history of life, people, anyway, faced with conflict, and, therefore, there is need for reflection and decision-making in the most correct emerging conflict situations. Studies carried out in this paper can be used as a possible way of resolving such conflicts.
