**Relevance of research topic.** Juridical conflictology is a new subject including common knowledge of conflictology and nomology also psychology and sociology. Juridical conflictology became popular in the xx century because of increasing quantity of conflicts on the post-Soviet territory. These conflicts were caused by culture differences, economic problems and political questions. As a result the new subject – juridical conflictology appeared with the purpose to analyze and resolve juridical conflicts. This discipline differs from conflictology so it resolves conflicts using development of juridical conflictology. The main work of low-enforcement authorities are: preventive measures and resolution of different conflicts. Official statistics shows that measures used by low enforcement agencies are not enough to reduce the number of legal conflicts among citizens of the Russian Federation.

The level of juvenile delinquency is more important for the country. The low-enforcement authorities and the Federal State Statistics Service analyze the level of juvenile delinquency annually. Today we have a lot of special programs that help us with the youth at risk. The main goals of these programs are the integration with the social system and the improvement of family environment. The problem of juvenile delinquency is very important because the youth has some problems inside and outside the family. The causes of the crimes among adolescents are: adverse family environment, poverty, negative pressure, corporal punishment, homelessness and neglect.
