Nowadays the problem of realization of the rights and freedoms of the person is particularly acute in Russia. There are many events at which systematic violation of the rights and freedoms of the person is observed on the global stage. Safeguards of the economic, social, cultural, civil, political and ecological rights are often broken. There is a need of enlightment of the population concerning the rights and freedoms of the person, their forms and methods of its protection. Without ensuring the rights and freedoms of the person the question of impossibility of the movement to democracy, freedom, legality and the constitutional state arise. In this regard such legal institute as institute of the Commissioner for Human Rights attract especial interest.

**The aim of the research** is to disclose the legal characteristics of the status Commissioner for Human Rights in the Russian Federation and to research problems of formation and development of institute of the Commissioner for Human Rights.

There is a need of fixing the rights of a legislative initiative for Ombudsman for the most effective interaction of the Commissioner for Human Rights in a territorial subject of the Russian Federation and representative bodies of the territorial subject of the Russian Federation.

Also it is necessary to establish a consequence of decisions in the legislation, which contain recommendations concerning possible and necessary measures for restoration of the violated rights.
