

SUMMARY

Subject of the thesis: Information security of Russia at the present stage.

Relevance of the research issue is due to the fact that in the twenty-first century one of the dominant factors in the present stage of global development has become a phenomenon, sometimes described as the "information revolution". The information revolution is a symbiosis of two developing throughout all stages of the evolution of social and political processes – the constant increase of the role and increasing the volume of information necessary for the viability of human society, and the process of development and improvement of technologies for collecting and disseminating information.

Universal Informatization has a significant impact on the international political situation and the future of each country, which is largely determined by the level of development of transport, information and technological infrastructure. For Russia, which today puts before itself the task of developing the information society, integration into the global information space, information security problems are becoming increasingly important

The purpose of the research issue is in the identification and evaluation of new challenges and threats to information security of Russia.

Research objectives:

- to explore the concept, scope and structure of informational security of the state;
- to classify the types and sources of threats of information safety of the state;
- to consider information security of Russia and its place in the system of ensuring national security;
- to identify problems and threats to information security of Russia.

Scientific novelty: The author obtained the following main results:

– investigates the concept of "information security", and identified that it is a complex, multilevel phenomenon, on the state and prospects of development which have a direct impact a variety of factors, which bears both internal and external nature.

– analyzed the information security of Russia, and revealed that the modern geopolitical situation requires a fundamentally different approach to the problem of security, including the improvement of the forms, methods and instruments for identifying, assessing and forecasting of threats, defending the national interests, goals and values of Russia in the global information space, as well as system to counter these threats.
