Topicality of the research: the Problem of formation and development of legal state and civil society is still considered unsolved and insufficiently developed in contemporary political and legal Sciences, while the study period is measured by centuries, and from time to time, it obscures many other problems.

With the proclamation of the Russian Federation of the democratic and legal state was the obvious necessity of development and civil society. After all, such a society is the basis of a legal state.

- to develop real mechanisms of interaction of associative groups and the state.
