Relevance of the research issue:

Today in the independent world, the diaspora is rapidly turning into a subject of law and policy with which to be reckoned. It is for this reason that they have become an object of increased public and political attention, which, in turn, update the task more depth and objective study of the role of diaspora in international relations and foreign policy of modern states. Particular scientific interest is the role of the Jewish Diaspora in Russia's foreign policy and to identify possible areas of cooperation with these ethnic communities living in the Russian Federation and in other foreign countries.

The purpose of the work is analysis of the role of the Jewish Diaspora in the foreign policy of the Russian Federation and the identification of possible areas of cooperation with it in the context of lobbying and national interests of Russia.

Research objectives:

- present the main approaches to the study of the concept of "diaspora" that exist in the domestic and foreign political thought;
- to identify the key policy features and capabilities of the diaspora as an instrument of foreign policy of the Russian Federation;
- to investigate the role of the Jewish Diaspora in the context of contemporary Russian diaspora policy;
- to determine the potential of the Jewish Diaspora in the context of lobbying and national interests of Russia.

Scientific novelty:

specified the basic strategies, challenges and priorities of the modern diaspora Russia's policy towards the Jewish Diaspora, identified the potential of Russian-speaking Jewish Diaspora in foreign countries in the context of lobbying and national interests of Russia.

Structure:

Summary:

In the current situation of the modern world one of the strategic objectives of Russian foreign policy is to strengthen the international image and promote the objective perception of Russia as an influential center of the modern world

community. One of the tools to strengthen the international influence of any country are foreign and diaspora communities. Of particular importance in this context is the task of the institutional organization of Russian-speaking population abroad in a single diaspora, which will act compatriots consolidated in the political life of foreign countries in general, and in the promotion of Russian national interests in particular.

In the context of the availability of potential lobbying Russian can be an important object of the largest Jewish diaspora has traditionally been seen as influential actors of the modern political life of many countries where a high percentage of the Jewish population. The experience of the Jewish Diaspora and presented it lobbies is interesting from the point of view of its potential use in the U.S.A, Israel, Germany and other countries in order to strengthen the internal unity of diasporas themselves, improve their operations, forming the structure of the Russian lobby and promote the interests of Russian foreign policy modern states.
