

## SUMMARY

**The research work relevance** is determined by its importance. It lies in the advent, the development, the management and the settlement of the interethnic conflicts in the Stavropol territory. The interethnic conflict, as the social phenomenon, is a collision of interests of different level and the contents, and represents the manifestation of difficult processes in the relations between the individuals, separate ethnic communities, different groups of people proceeding under the influence of a set of social and economic, political, psychological, territorial, separatist, historical, language, cultural, religious and other factors. The main factors that can have an impact on the interethnic conflicts, in the Stavropol territory can be: the national structure of the region in which there a conflict happened, the social status of the population, political views, the religious structure of the population, the territory.

Quite often, representatives of this or that ethnic community, try to emphasize the ethnic origin, religious, national or cultural features. In opposition to the tendencies of the globalization the local and group interests which are often based on protection of cultural and other values, connected with originality of the separate ethnic groups are protected.

The interethnic conflicts strongly occupied one of leading places in public consciousness of the Russian society. Escalation of the ethnic conflicts in Russia in many cases is connected with the general situation connected with conflicts in the

society, the existence of the powerful social splits increasing the probability of an aggravation of the conflicts in the country.

**The object of the research** is the interethnic conflicts in the Stavropol territory.

**The research subject is** the reasons of conflict advent and the ways of settlement of the interethnic conflicts in the Stavropol territory act.

**The research purpose is** the examination of the factors, conditions and ways of the permission of the interethnic conflicts.

**The research goals:**

- to investigate the concept and the essence of the interethnic conflicts;
- to establish the reasons of emergence and the stage of the development of the interethnic conflicts;
- to consider the features of the emergence of the interethnic conflicts in the Stavropol territory;
