

## SUMMARY

**Relevance of the research issue:** In the Russian Federation the international economic relations have been developing for many years. Given the growing influence of global economic relationships in the social and financial development, Russia is facing such issues as paramount: the promotion of foreign trade performance, mobilization of foreign investment, providing a unified Russian competitiveness in an interconnected global economy. Evaluating the results of the past decades, it can be assumed that international and foreign economic relations of the regions have become fundamentally important component of relations between the Russian Federation and foreign countries. This kind of communication contribute to the formation of "neighborhood belt" that produces a positive image of Russia and, ultimately, a more successful integration of our country into the world economy. Also important for Russia plays its entry into the WTO. Speaking about the subjects of the Russian Federation, in particular the Republic of Ingushetia, Russia's accession to the World Trade Organization as a whole, a significant impact on the operations of the republic will not. However, if participation in the WTO will help to modernize the Russian economy as a whole, it will undoubtedly have a positive impact on all regions of the Russian Federation.

To supply the growing activity of the enterprises of the Russian Federation in the implementation of foreign policy requires a constant search for forms and methods of promoting foreign trade, including trade and mediation. All this determines the relevance and practical significance of the work.

**The purpose** of the work is a comprehensive study of foreign trade of the Republic of Ingushetia as a subject of the Russian Federation.

**Research objectives:**

- prove that the foreign economic activity is an element of foreign policy;
- consider the role of the Ministry of Foreign Affairs of the Russian Federation in foreign economic activity;
- classify the legal framework governing foreign economic activity of the subjects of the Russian Federation;
- explore the concept of foreign economic activity of the Republic of Ingushetia;
- analysis of foreign trade of the Republic of In-Ingush.

**Scientific novelty:** lies in the fact that for the first time identified factors that influence both on the reduction of foreign economic activity of the Republic of Ingushetia and enhance its qualitative and quantitative component, based on the analysis of the Concept of foreign economic activity of the Republic of Ingushetia copyrights are formulated recommendations for improving the strategy of international and foreign economic relations of the Republic of Ingushetia; STI identified opportunities to expand export capacity and the expediency of regional exports from the perspective of compliance with the range and quality needs of the global market, developed recommendations to improve the mechanisms of formation of favorable economic, legal, organizational and other conditions for the conduct of foreign economic activity at the level of the federation and how to implement them ; copyrights are proposals for a national and regional measures to support the development of foreign trade of the Republic of Ingushetia.

**Summary:** This work is dedicated to the study of movement and formation mechanism of the foreign economic activity of the Russian Federation.

In Russia, the study of the doctrine of the foreign economic activity in the criteria for transition economies initiated no so long ago. As a result of work, we can summary following decisions:

1. The unit of the foreign economic activity captures the special space in the management of the economy, due to the fact that a foreign government relationships is integrated into the larger economic integrity. Along with state foreign economic entities are considered foreign control of either system.

2. The unit of the foreign economic activity of the Federation, analyzed in the case of the Republic of Ingushetia developed on the basis of dividing the opportunities in the field of foreign trade between the Russian Federation and the Republic. Its properties are due to the degree of federation capabilities and its subject, the nature of the main problems. At the federal level marks the customs regulation, a single execution of monetary, economic, fiscal, monetary policy. Together with the fact the division of opportunity between the federation and the subject of the last execution involves personal credit, tax policy.

3. Performance of the developed concept of a mechanism of the foreign economic activity of the Russian Federation will provide an opportunity through differentiation purposes, configurations, processes and resources to the most productive regional economic use external economic opportunities of individual regions and subjects of the Russian Federation.

4. In the structure of the existing mechanism of foreign trade of the Republic of Ingushetia is expedient to establish associations of foreign residents of the republic, as well as producers of export - oriented products. This will give the mechanism of the foreign economic activity of great reliability and activity due to allegations of close ties with the business community, at the same time ensure the achievement of consensus in decision-making in foreign trade, taking into account the opinions of all interested parties.
