Topicality of the research into the political processes is determined by the intention of the political subject to exercise influence on the course of the political events important for the life of the society.

The object of management in this plane is the political process. The political process as the aggregate of facts, events, actions of the subjects of policy and their interactions that have public-power significance is developing in the dialectical unity of self-organization and purposeful activity.

Many problems in the sphere of the center-periphery political relations are conditioned by the lack of a clear-cut mechanism of the realization of the decisions made. There exists parallelism and duplication in the work of the organs of state power in the Russian Federation, their poor interaction with the organs of state power of the subjects of the Russian Federation in the North Caucasus, specifically in the Karachai-Circussian Republic, the insufficient use of the possibilities of the political parties, public organizations and ethno-cultural movements, traditional methods of people's democracy.

Objective of the research:to reveal the factors, goals and methods of management of the political processes in the Karachai-Circussian Republic.

Tasks of the research:

– to interpret the theoretical comprehension of political processes management as a type of the activity of the subject of management;

- to determine the main content and parameters of political processes as an object of management;
- to reveal the system of the subjects of management of political processes at the regional level;
- to comprehend the effective forms and methods of management of political processes at the regional level;
- to reveal the problems and contradictions of the youth participation in political processes on the example of the Karachai-Circussian Republic;
- to develop the project of the Karachai-Circussian Republic Youth Government as an innovative technology of the optimization of management in the sphere of the political processes in the Karachai-Circussian Republic.

Theoretical and practical significance of the research:the study of management of the political processes in the Karachai-Circussian Republic and their role in modernization promotes the verification of certain management categories. The attention to management in the sphere of political processes enables one to better understand the specific features of its management.
